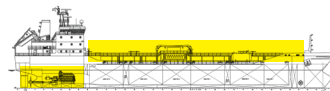

APPLICATION

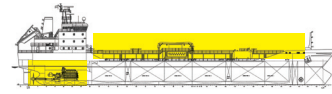
Use continuously by injection dosing pump or spraying. Usually start with 20 ppm and reduce amount depending on foam quantity.
